# WHEN YOU GET ARRESTED - DO'S AND DONT'S

"As human rights defenders and leaders, it is crucial to know what to do if you are arrested, ensuring you can protect yourself and advocate for justice effectively through clear, step-by-step actions."



# Imagine you are arrested and arrange the following steps in the order you believe they should be followed in response.

STEP	1-5
If you are physically injured by the police during your arrest, seek medical attention and inform your medical providers of the cause of your injuries. Take photographs of your injuries as soon as possible.	
Clearly inform the police that you will not speak to them about anything without a lawyer being present.	
Ask for the police officer's name and badge number or read it off his/her badge. Try to remember it. Try to get a good look at the officer's face so that you can identify him or her later by that method, if necessary.	
Ask if you are under arrest. If you are, you have the right to be told why.	
As soon as you can, write down everything that happened during your arrest so that you can use that writing to refresh your memory later.

# PRACTICE DOCUMENTING AN INCIDENT

"It is very important to know that the police must not treat you in an inhumane or degrading way, or torture you during investigative activities e.g. beating or threats. If you are mistreated, it is imperative to know how to document the incident and take the proper next steps to protect yourself. Practice documenting an inhumane scenario below."

1	Descriptive details (where, what time, who's involved, etc.)	
		<b>Examples:</b> <i>In my red Toyota at 7:30 PM by a city police officer.</i>
		<b>Tip:</b> Include as much detail as possible, colors, brands, names, streets, cities etc.
2	Sequence of events	
		<b>Tip:</b> Note what you were doing before, during, and after the incident took place. Record the sequence of events as soon as possible.
3	Medically related details	
		<b>Tip:</b> If possible have a trusted individual help you identify and document any injuries. Keep any medical documents and securely store images.
4	Next steps	

# INTERNATIONAL HUMAN RIGHTS AND RULE OF LAW

"To prepare for an event my organization is hosting, I worked with my team to develop an action plan outlining steps to take if one of us is detained. My plan includes a strategy for communication channels and securing legal representation to ensure my rights are protected."



The effective implementation of international human rights norms is premised on adherence to the rule of law, i.e. that no person is above the law, and that the law applies to every person equally, without discrimination, whether a person is a private citizen or a public official.
